Speaker: Heather McCalla

Heather McCalla, a San Diego native, is a designer and craftsperson of unique objects and fine furniture. Her interest in art began at a young age and continued to develop, manifesting itself in various forms, as she advanced through school. When she began attending San Diego State University in 2002, she was still unsure of what discipline she wanted to pursue. Each semester she would take classes in the art department and eventually discovered woodworking while enrolled in a crafts course. She instantly fell in love with the process and, having discovered her passion, avidly pursued it in the furniture design program under the tutelage of Wendy Maruyama. In 2006 she obtained her Bachelors degree in Applied Design and has since begun showing her work. She continues to work in San Diego and remains heavily involved with the San Diego State University furniture program as a teaching assistant and volunteer.

This month she will talk to us about how to make and use milk paint. This process will include a live demonstration and samples of things she has done with the paint. Hope you can attend.

Shop Tour

SHOP TOUR HELP WANTED

The New Year is here and your devoted directors are hoping for something of a new look in shop tours for 2009. Specifically I am asking you to help me identify two kinds of shops in San Diego County:

- 1. Exceptional woodshops that you know about and think other members would like to see. Such shops would be the kind we have been seeing all along in our regular tours, shops with WOW! features.
- 2. Realistic home woodshops that most of us could at least hope to have someday. These shops would be for a different purpose, intended to appeal to the majority of members that see woodworking as a cool hobby, or for an occasional project, but who haven't the budget or space, or perhaps time, for a dream shop. I'm hoping that new members, especially, will find these practical shops especially interesting and pertinent to their needs.

The realistic shop I'm thinking about has been built in a garage or basement or a spare room or a trailer or some other clever bit of space. The key idea for a realistic shop is that it works for the woodworker; the available space, budget and equipment have been brought together successfully. It does not have to be elaborate, or pretty, or roomy, or even clean, but it does the job and the sawdust flows happily. Perfection is not expected, just workability. In other words, it would show how the inspired, but perhaps resource-limited, amateur woodworker solves his/her shop problems.

With these small home shops, after the owner's enthusiastic agreement, a small local group of members (maybe 5-10), who had expressed prior interest, would be invited to visit. Discussion would emphasize how shop set-up problems were solved, and point up the special skills and interests of the owner, hopefully with a demo or two. I would coordinate/arrange these local tours. If this leads to subsequent visits and collaborations among the local members, would that be a bad thing?

If you have suggestions for either kind of shop (including your own!), let me know. I will get back to you immediately. The realistic shop tour is mainly just an idea now, but one we believe would help members get more out of the SDFWA. Thanks much for your help!
