### **DESIGN IN WOOD**

It is March and the 28th Annual Design in Wood Exhibition is just around the corner. Here are some dates to remember.

**SIGN UPS** for volunteering at the Fair start with this month's General Meeting, March 25. I will explain how you can do this at the end of the article

ENTRY DEADLINE: May 1, 2009 SET UP - STAFF & COMMITTEE ONLY: May 17, 2009, Sunday SET UP - ALL HANDS: May 18 - May 21, 2009 Monday - Thursday TIME: 8:30am each day ENTRY DELIVERY: June 4, 2009 12:00 noon to 8:00pm **FAIR DATES**: Opens – June 12, 2009 11:00am (Awards 7:00pm) Closes – July 5, 2009 NOTE: The Fair will be closed on Mondays, June 15 and June 22 ENTRY RETURN: 12:00noon to 8:00pm July 6. 2009

Remember, this is your exhibit and SDFWA's number one activity for the year. We need everyone to be involved in some way i.e. **ENTER, HELP WITH SET UP, VOLUNTEER AT THE EXHIBIT**, **HELP WITH TAKE DOWN**. We will provide great food and refreshments along with a generous number of free passes to the Fair just for a few hours of your time. Everyone gets two (2) passes for each shift they sign up for and four (4) passes a day for set up and take down volunteers. You even get passes for entering.

Here is how you sign up to volunteer in the 19th Century Chair Shop or to be a gallery floor walker.

### NEW SYSTEM THIS YEAR

This year there will be several ways for DIW volunteers to sign up for the shifts wanted. In the past you could sign up at the General Meeting or you could call or email volunteer coordinator, Eric Lunde, with the date and times you wanted after getting the available dates and times from the SDFWA web site. These options are still available to you this year plus an addition of a New System to completely sign up online.

### **NEW METHOD**

To sign up online, go to the SDFWA web site. You will need your membership number from your membership card and your email address that's on file with the SDFWA (the one you used on your membership application). You will be asked for these items on the log-in page. If your member number and email matches our data base, you will be taken to a log-in page where you will create an ID and password for the web site. (This log-in ID and password will enable you to not only sign up for DIW volunteer shifts but will also enable you to access, later this year, our new section for members only on the website). After you have logged-in, you will be taken to a volunteer sign up page where you and/or your spouse can reserve volunteer shifts in the shop or gallery.

Sign ups will start at the March 25th General meeting. Following that meeting, you can sign up online at SDFWA.org.

If the computer method or meeting sign ups are not possible for you, please call Eric Lunde at 858-487-7644 and leave your name, phone number and dates and times you desire and Eric will enable this for you depending on availability of the dates and times. If the times are already taken, Eric will call you back with alternatives.

I want to thank Doug Murphy, our web manager, and Eric Lunde for all their help with this new system.

Must be USPS Postmarked on or before Friday, May 1, or submitted on-line by 5:00pm (Pacific Time), May 1.

Delivery of exhibits: Thursday, June 4, Noon - 8:00pm

Exhibitor Awards: Friday, June 12, 7:00pm - 9:00pm

Pick-up of exhibits: Monday, July 6, Noon-8:00pm.

### **CONDITIONS OF ENTRY**

- Who can enter? The Design in Wood Exhibition is open to all interested adult woodworkers. Wood projects must have been created by artist whose names appear on the entry form.
- How many entries can I submit? A maximum of three entries, all classes combined, may be submitted per entrant. Works previously displayed in this Exhibition are not eligible.
- Is there a fee? The processing fee is \$20.00 per wood project entered. Processing fees are non-refundable.

How do I enter? Registration is required. Late entries will not be accepted.

- On-line registration: Entries must be submitted at www.sdfair.com/entry by 5:00pm (Pacific Time) on Friday, May 1 On-line entries will receive an e-mail confirmation.
- Mail in registration: Completed forms and fees must be USPS postmarked on or before May1. You will not receive a return receipt.
- Hand delivered registration: Completed forms must be delivered to the Entry Office, Del Mar Fairgrounds on or before May 1, 5:00pm.

#### What are the project requirements?

Projects that do not adhere to the requirements specified will be disallowed.

Projects, any portion of which was produced under the supervision of an instructor or those constructed from kits, are not eligible.

You must provide either color 4" x 6" photos or digital photos of your work, with no more than three views per entry. Each photo must show the entrant's name and item number to correspond to the entry form. Photos will not be returned. Photos of unassembled projects are not acceptable. Online entries submit photo as attachment 4 inches (400 pixels) x 6 inches (600 pixels) at 150 DPI and not to exceed 750KB in file size.

Entries that are unsuitable or require excessive display space may be disallowed by Fair Management.

Entries must be primarily made of wood.

Entries will be juried for acceptance into the show. Notification of your participation will be mailed prior to the delivery date.

When do I bring my exhibits? Notification of your participation will be mailed prior to the delivery date. See calendar for delivery date and times. Deliver exhibits to the Del Mar Fairgrounds Mission Tower Building. Access the Fairgrounds through the Solana Gate off of Via de la Valle. No works will be received after this time. You must bring the projects described on the entry form. Claim checks will be issued when delivered.

Shipping Instructions: Small exhibits may be shipped, pre-paid, to arrive at the San Diego County Fair Entry Office between May 28 and June 3, 2009.

For return shipping of entries, a pre-paid return label from UPS must be included with your entry.

- When do I pick-up my exhibits? All exhibits must be picked up on date and time specified in calendar. Exhibits may not be withdrawn before the close of the Fair. You must present your claim checks in order to pick-up your exhibits. If you are unable to come during specified time, please arrange for someone else to pick up your exhibits. That person must bring the claim checks and a signed, written authorization from you. Exhibits not picked up at this time become the property of the Fair and will be disposed of promptly.
- How can I sell my work? All work on display will be considered for sale at the price indicated on the entry form. Work not for sale must be marked NFS on the entry form. Work not priced will be considered NFS. Sales inquiries will be collected and passed to the exhibitor when entries are picked up. No sales are allowed during the Fair. All sales will be the responsibility of the exhibitor.
- What is the judging procedure? Judging panels will consist of woodworkers and professionals in the industry. The following judging criteria will be used for all classes: Design Integrity; Understanding and Use of Materials; Use of Form and Color; Overall Craftsmanship; and Appearance and Quality of Finish. All selected entries and award winning works will be displayed during the run of the Fair. The decision of the judges is final.
- What else do I need to know? No entry will be accepted where the exhibitor describes conditions under which he/she will exhibit. Every effort is made to protect all exhibits with a secured, protected and alarmed exhibit space. Neither the San Diego County Fair (22nd District Agricultural Association) or the San Diego Fine Woodworkers Association will be responsible for any loss or damage of any kind. The Local and State Rules apply to this department. Copies are available at sdfair.com/entry or contact the Entry Office.

### For your information

Lowe's was started in 1946 as a single store in North Wilkesboro, North Carolina, by two brothers-in-law, James Lowe and Carl Buchan. Within a few years Buchan bought out Lowe but kept the Lowe's name, possibly because he liked the sound of "Lowe's Low Prices." Buchan died in 1961, the same year the company went public. Lowe's began trading on the New York Stock Exchange in 1979, and by 2004 its sales totaled \$36.5 billion. As of 2005, Lowe's operates more than 1,100 stores in 48 states.

Home Depot was founded in 1978 in Atlanta, Georgia, by Bernard Marcus and Arthur Blank, two top executives who had recently been fired from Los Angeles-based Handy Dan (another home improvement chain), and Kenneth Langone, a New York investment banker who helped the pair gain the financing they needed to launch their venture. The company went public in 1981, and by 2005 the parent company, The Home Depot, Inc., was operating more than 1,800 stores (Home Depot, EXPO, and other subsidiary companies) in 50 states, the District of Columbia, the ten Canadian provinces, Mexico, and Puerto Rico. While Home Depot does not yet have stores in China, it did recently open two sourcing offices in that country.
